#### From the Village of Elkhart

Per **Ordinance 90-6 Regulating and Controlling Nuisances**, animals which are left free to roam within the Village are considered nuisances. Such animals will be trapped by the Village and sent to Logan County Animal Control. Offenders whose pets are captured will have to pay a fine prior to their release.

Ordinance 90-6

# REGULATING AND CONTROLLING NUISANCES Within THE VILLAGE OF ELKHART, LOGAN COUNTY, ILLINOIS

BE IT ORDAINED by the Board of Trustees for the Village of Elkhart. Illinois:

Section 1. Definitions

- A. Administrative Officer shall mean the legally designated President of the Board of Trustees for the Village of Elkhart, or his/her authorized representative.
- B. Animal shall mean cattle, swine, horses, mules, donkeys, sheep, dogs, cats, goats, rabbits, or any other animal; and chickens, turkeys, geese, pigeons, doves, ducks, or any other fowl; or any reptile including snakes, lizards, and turtles.
- C. Disposal Site shall mean an area of land serving as the central location receiving consolidated refuse from one or more sources.
- D. Enforcement Officer shall mean the Administrative Officer, or his/her authorized representative.
